Male preference in India

Female infanticide

Infanticide in India is sadly widespread, with girl children as the focus. Because of the social pressure for sons, infant girls may be deliberately killed soon after birth, either by their mothers or by other family members with or without the permission of the mothers. Older girls may be lethally neglected; according to the Invisible Girl Project, “the mortality rate for girls between the ages of 1 – 5 is 75% higher than the mortality rate for boys of the same age.”

Jill McElya lived in India in 2009 and what she saw motivated her to found the Invisible Girl Project. C-FAM says, of her testimony during the Smith hearings (see next column), “She told a story of a girl who was the twelfth daughter in her family, but the only one who was allowed to live. Her other eleven sisters were killed by her parents after they were born in hopes that later they would have a boy. Abortion of girl babies

Not surprisingly, the abortion is frequent in India, but only for babies who are identified prenatally as being female. Congressional Representative Chris Smith, who is chairman of the subcommittee on Africa, Global Health and Human Rights, held hearings on the topic of gendercide in India. “Witnesses told of General Electric selling thousands of ultrasound machines to private clinics despite sex-determination being illegal.”

To a witness who decried “gender-biased sex selection” but who insisted that there be no limits on abortion, Smith said, “Prejudice against the girl child and women . . . begins in the womb.” www.c-fam.org/en/issues/global-health/7528-u-s-congressional-hearing-examines-gendercide-in-india

The Hindu, an Indian newspaper, reported “a significant decrease in access to abortion drugs since the middle of 2012 following the 2011 Census results that created a nationwide alarm by revealing the worst-ever child sex ratio.” One official said, “Our ability to offer safe abortion drugs has been severely compromised. . . .” That “compromised ability” to abort probably saved many lives.

Great Britain: sex-selection abortion illegal but not prosecuted

National Right to Life notes: “British Health secretary Jeremy Hunt has written to attorney general Dominic Grieve asking for ‘urgent clarification’ after the Crown Prosecution Service (CPS) decided it was not in the public interest to pursue the case against abortionists who agreed to abort a child because the mother said she did not want a girl.”

They note the inexplicable, but not unexpected, silence from feminist groups.

The Rhode Island Exchange offers only plans that cover abortion

As ObamaCare kicks in, new details are emerging regarding its pro-abortion effect in the Exchanges around the country. It is bad enough that federal premium subsidies will be paid to Exchange plans that cover elective abortion in the 27 states that have not passed a law opting out of abortion coverage, but now, for some pro-lifers, the only plans that will be offered in their state Exchange will be plans that cover abortion.

In testimony on September 12 before the Rhode Island House Committee on Finance, the Director of the Rhode Island Exchange confirmed that all of the health insurance plans on the Rhode Island Exchange will cover abortion.

The Rhode Island Exchange will not even have a federally administered multi-state plan that doesn’t cover elective abortion. ObamaCare requires each Exchange to have at least one federally administered (continued on page 2)

multi-state plan that doesn't cover elective abortion. But this requirement is phased in and the federal government has until 2017 to implement a multi-state plan in every Exchange. Rhode Island is not among the initial states in which a multi-state plan will operate.

The federal government gave over \$82 million to the state of Rhode Island to establish its Exchange. The result? A marketplace exclusively for abortion-covering plans.

As the Exchange plans go online, pro-lifers will have to ferret out which plans in their respective Exchanges do not cover elective abortion.

Twenty-three states have enacted "opt out" laws, in various forms, that will prevent Exchange-participating insurance plans from covering abortions. An up-to-date listing is posted on the NRLC website

Hobby Lobby and the Supreme Court

The Obama administration has requested the Supreme Court to decide the Hobby Lobby issue. Hobby Lobby is one of the companies that have gone to court saying that complying with certain mandates of ObamaCare would require them to violate their religious principles in the taking of innocent human life.

There are many such cases that have been working their way through the court system. The companies argue that the HHS Mandate is unconstitutional and that it violates the Religious Freedom Restoration Act (RFRA).

Breitbart legal columnist Ken Klukowski points out that the HHS mandate is not part of the ObamaCare legislation that was passed by Congress, but instead it is a regulation referring to "preventive services." Presumably the "disease" that is being prevented is pregnancy, defined as such so as to make it fall under the scope of issues that the legislation said would be decided by the Secretary of HHS.

Public and business "uninformed" on ObamaCare

A poll by the Washington Post/ABC News, released September 20, says that 62% of the poll respondents said they do not have adequate information on ObamaCare.

That attitude was confirmed locally by the experience of Chris Wiest, vice president for public policy and advocacy at the Rochester Business Alliance. He was giving presentations at local public libraries. He commented to the Democrat and Chronicle that he found a striking "level of confusion and uncertainty" about what businesses had to do to comply with the law. For instance, most people did not know that employers were required to inform their employees about the coverage mandate and that the notification had to be done by October 1.

Considering that the original bill itself was huge, it is not surprising that there is a lot that is new to most people.

British deaths from neglect

Professor Brian Jarman, an expert on hospital performance, said that British hospital patients were at risk of dying from poor care, almost 50% more likely to die from poor care than in American hospitals, with, for example, a higher risk of dying from pneumonia and blood poisoning.

He developed an analytical method, the "hospital standardized mortality ratios" (HSMRs), which compensates for such factors as the age of the patient and the severity of the disease, allowing a determination of which deaths would reasonably be expected and which ones would not.

The director of the British National Health Service, Bruce Keogh, was quoted as saying, "The fact is we have a health service that is admired around the world, founded on the cradle to grave principle. But the other fact is we still have too many patients dying in our hospitals when their relatives were expecting them to come home."

Pope's quote had pro-life Catholics concerned

The media were overjoyed. However, pro-life Catholics who followed the news were understandably startled and dismayed by reported comments made by Pope Francis during a long and exclusive interview. They received the distinct impression that he was interested in "loosening" the Church's "small-minded rules" on controversial issues like abortion.

Many Catholics responded, prompting a clarification from the Vatican:

"The pope is not condemning his predecessors," Vatican senior communications adviser Greg Burke told the Associated Press. "What he is saying is 'We've spent a lot of time talking about the boundaries. We've spent a lot of time talking about what is sin and what's not. Now let's move on. Let's talk about mercy. Let's talk about love.'"

The Pope has since spoken forthrightly about the evil of abortion.

Rochester pregnancy centers coordinate with a toll-free 855 telephone number

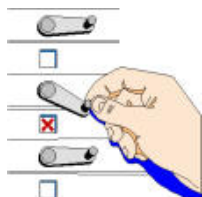

When a woman, sometimes just a young girl, suspects she is pregnant, she frequently does not know where to turn. She may enter the doors of an abortion clinic because she fears the response of loved ones, the baby's father, or because she has been told that abortion is her "best" option despite the loss and grief she will experience if her child is no more. Several such women were observed entering the Planned Parenthood facility during last year's 40 Days for Life. The prayerful people in attendance wanted a simple way to get the pregnant women the supportive services she needs to carry her baby to term, the best option for mother and baby.

In an answer to this need, with the generosity of local donors and the collaboration of the Pregnancy Resource Centers that cooperatively share the pregnancy confirmation ultrasound services in Monroe County, a phone number has been established (585.340.1354 or 855.755.5935) to receive calls. Any woman may call these numbers, regardless of the time of day or night to be put in touch with a Pregnancy Resource Center of her choice, to get the help she needs. This program, an extension of the Ultrasound Program, is another sign that life is best protected when we work together.

Since you asked: “Fetuses aren’t really persons, are they? They aren’t developed enough until birth.”

Answer by Dcn. Dennis Lohouse

Pro-choicers will often say that the unborn is less developed than a newborn, so they are not fully human. If we extend this argument, then a newborn is less developed than a toddler. A toddler is less developed than an adolescent, and an adolescent is less developed than an adult. Even a mentally handicapped adult or a "developmentally delayed" child might not be as developed as a toddler. The reality is that at conception a child is fully human by virtue of its DNA. Since it can be argued that humans do not reach full development until adulthood, it is nonsensical to argue that the unborn are non-human on the basis of their level of development.

“Abortion’s the only answer. Nobody would want a child like that!” *Hmm ... are you sure?*

"There is a couple in another state who have contacted an adoption agency looking for a family to adopt their Down syndrome unborn baby. If a couple has not been found by today they plan to abort the baby. If you are interested in adopting this baby please contact Fr. VW IMMEDIATELY."

That's what the church's Facebook posting said.

In the morning the rectory phones were ringing off the hook. Hundreds of people called, from all over the US and from other countries, too. The staff of Trinity Catholic Church in Gainesville, Virginia, struggled with the flood of calls. Martha Drennan, church employee, drafted a young seminarian to help answer the phones. She said that "if you added up all the emails in Fr. Vander Woude's account and all the phone calls it'd likely be over a thousand couples willing to adopt the child."

Not really a surprise, is it?

Jennifer Anderson, of Bethany Christian Services here in Rochester, was asked if it was difficult to find adoptive parents for a child with Down syndrome. She said there were several local couples who had already adopted a child with Down syndrome or who were hoping to adopt such a child. She said, "I have found with education and awareness people not only respond with a desire to parent a child but respond with excitement to have the honor of including such a special child into their homes, families and communities."

She said they are involved in a new program called the Bamboo project, working with China for adoption of children with Down syndrome. Details can be found on www.bethany.org/180

Progress in Down syndrome research

Down syndrome occurs when there is an extra copy of a specific chromosome, chromosome 21, so that there are three instead of just two. Researchers have just found a way to "silence" the third copy of the chromosome using a naturally occurring gene that they transfer to the extra chromosome.

In the lab, cells corrected by silencing the extra chromosome grew better and developed more swiftly. Researchers say that the success is "the major first step towards potential development of chromosome therapy." The development of full chromosomal therapy, if even possible, is many years away. However, the leader of the research team notes potential earlier benefits.

"This will accelerate our understanding of the cellular defects in Down's syndrome and whether they can

be treated with certain drugs," said Jeanne Lawrence, who led the team at the University of Massachusetts.

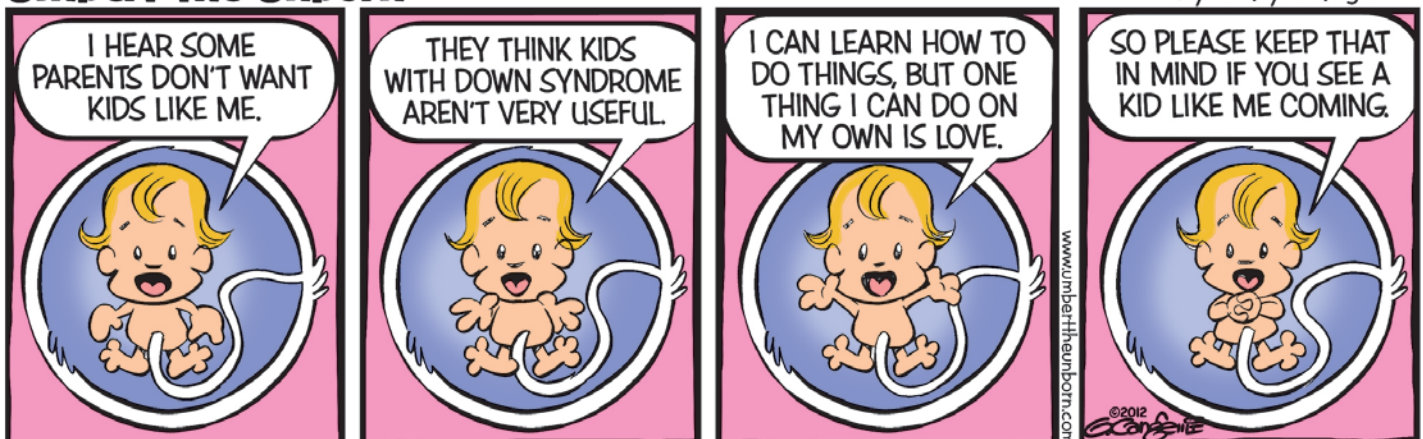

WASHINGTON Legislation

Health Care Conscience Rights Act H.R. 940. Introduced by Representative Diane Black, this would amend ObamaCare to protect Americans from being compelled to provide (e.g. with our tax money) or participate in acts like abortion that violate moral convictions. The National Right to Life Committee (NRLC) approves of this bill.

Follow the Money Act S. 791. This insidious bill would institute more regulations aimed at nonprofit advocacy organizations that communicate with the public about legislative and political matters. The overseers of the program would be the IRS and the Secretary of the Treasury. The NRLC opposes this bill.

Pain-Capable Unborn Child Protection Act H.R. 1797. This would protect children by prohibiting abortion after 20 weeks; it was passed by the Republican-majority House. The Senate has not voted on it and the President has announced that he would veto it. The NRLC supports this bill.

NEW YORK STATE Legislation

The WEA (the Women's Equality Act), containing abortion expansion wording, was defeated in the NYS Senate, but only by a slim margin. (See the previous issue of Life-Lines.)

The "harsh measures" that worry the abortion advocates in the box at the right are the ones that would protect women and their unborn children. So, if you have not already done so, thank your Senator and Assemblyman if they voted against the abortion plank of the Governor's bill.

The Sex Selection Abortion Ban (S.2286 (Ball) / A.2533 (Crespo)) would ban abortions that were done because the unborn child was not of the desired sex. Discrimination inside the womb is no more acceptable than discrimination outside of the womb.

Abortion advocates concerned!

Pro-"choice" women scheduled a presentation in late September to discuss why the "abortion rights" measure failed. It was sponsored by WELD (Women's Equality Liberation and Defense), Rochester NOW, the Genesee Valley Chapter of the NYCLU, Metro Justice, and Planned Parenthood of the Rochester/Syracuse Region Action Fund.

The announcement wonders, "Where do we go from here? Is New York at risk for harsh anti-abortion laws being passed?"

Viewed with suspicion in Australia?

The Adelaide Catholic diocese in Australia is apparently concerned about what kinds of information might be given to parishes to publish in their bulletins. The Vicar General, Fr. Philip Marshall, has published a notice requesting that the parishes "not publicize in our church bulletins the material you may receive from time to time from Forty Days for Life or other similar organizations...." His concern is that although the Church speaks with one voice that "this is not always so among other organizations"

He concedes that these organizations do indeed "share our deep concerns for the protection of life and the unborn" but nevertheless does not seem to want individual parishes to decide what information to publish in their bulletins.
